



SUGGESTED GUIDANCE FOR CAMPGROUNDS

GENERAL OPERATIONS

- Physical distancing, enhanced cleaning and disinfection, and enhanced workplace safety best practices established for all businesses should be followed
- A minimum of 20 feet should be maintained between units for all lots rented for short-term stays of less than 10 nights
- Employees in public-facing areas are recommended to wear cloth face coverings over their nose and mouth at all times
- Campground operators should strongly encourage customers to wear cloth face coverings over their nose and mouth
- Provide handwashing in restrooms and sanitizing stations for guests and employees. If any campground cannot adhere to these requirements, it must close common restrooms and shared facilities.
 - Campgrounds should consider the recommended precautions from the CDC regarding COVID-19

OWNERS

- Campgrounds must increase routine cleaning and disinfection procedures with emphasis on frequently touched surfaces (e.g. door handles, counters, light switches.) These frequently touched surfaces should be routinely disinfected at least every 2 hours during normal hours of staff operation
- Campgrounds should monitor groups to avoid and prohibit gatherings
- Campgrounds should post signs promoting proper handwashing and sanitation
- Campgrounds should provide and check frequently to maintain supplies for handwashing

SHARED ACTIVITY AREAS

- Guests must adhere to social distancing guidelines during recreational activities and must adhere to social gathering guidelines
- Hot tubs, spas, and contact sport activities are not recommended
- Shared equipment during activities must be cleaned and disinfected after each use
- Campgrounds should monitor use of and post reminders for properly cleaning and social distancing near picnic tables, trash cans/dumpsters, and communal water areas

EMPLOYEES

- Training should specifically cover topics like cleaning restrooms and collecting garbage
- Campground employees should stay home if showing symptoms of illness
- Campgrounds should set up a means of communicating with guests in ways that include no in-person contact, including at check-in



SUGGESTED GUIDANCE FOR CAMPGROUNDS

CAMPGROUND GUESTS

- All gatherings should be limited or restricted to social gathering guidelines
- Campgrounds should monitor all public areas to encourage social distancing of guests. To achieve social distancing, guests should maintain 6 feet between persons not in the same household
- Guests should also be encouraged to bring disinfecting cleaners and hand sanitizers
- Develop a protocol to conduct a health screening for guests at time of reservation and at time of check-in. Require guests who have been sick or have symptoms to stay home
- Guests over 65 or with high-risk medical conditions are strongly recommended to stay home
